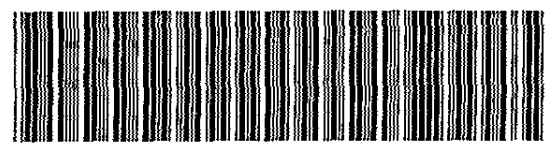


### ARTICLE FOUR CAPITALIZATION


