

ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms a professional corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the professional corporation shall be as follows:

JANET CARNEY CROOM, P.A.

The principal place of business of this professional corporation shall be 3333 20th Street, Vero Beach, Florida 32960, and the mailing address shall be the same.

ARTICLE II. NATURE OF BUSINESS

This professional corporation shall engage or transact in any and all lawful activities or business permitted under the laws of the United States; of the State of Florida; or of any other state, country, territory, or principality. Specifically, the professional corporation shall provide legal services.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this professional corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having One and No/100 (\$1.00) Dollar par value per share.

ARTICLE IV. ADDRESS

ARTICLE V. TERM OF EXISTENCE
