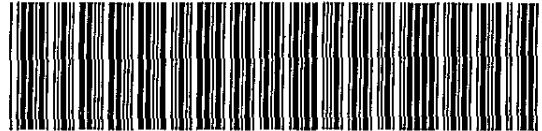



**ARTICLES OF INCORPORATION  
OF  
LA MEDIA PUBLICATIONS, INC.**

**ARTICLE I  
NAME**

The name of this corporation ("Corporation") is **LA MEDIA PUBLICATIONS, INC.**

**ARTICLE II  
DURATION**

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

**ARTICLE III  
PURPOSE**

The corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV  
INITIAL PRINCIPAL OFFICE**

The street and mailing address of the corporation's initial principal office is:

**ARTICLE V  
SHARES**

The total number of shares which the corporation shall have authority to issue is 1,000 shares with a part value of \$0.10 per share.

**ARTICLE VI

declaration of unlawful dividends or unlawful stock repurchases or redemptions, or (iv) a transaction from which the director derives an improper personal benefit.

Any director or officer who is involved in litigation or other proceeding by reason of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.

## ARTICLE X OTHER PROVISIONS



**Director or Officer Interest.** In the absence of fraud, no transaction between (a) this corporation and (b) any other association, corporation or any director or officer of this corporation individually, shall be affected by the fact that any director or officer of this corporation is individually a party to the transaction or is interested in or is a director or officer of such other association or corporation.


