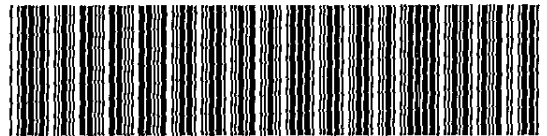

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge, and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of Florida.

ARTICLE I
CORPORATE NAME

The name of the corporation shall be BRIDGE CONCEPTS, INC.

ARTICLE II
CORPORATE PURPOSE

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE III
CAPITAL STOCK

The aggregate number of shares that the corporation has authority to issue is two hundred (200) shares, all of which shall be common shares without par value.

All of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this Corporation. The payment thereof does not have to be at the time of issuance, provided that the said shares are subject to calls thereon until the whole consideration thereof shall have been paid.

ARTICLE IV
CAPITAL STRUCTURE

The amount of capital with which this corporation shall commence business shall not be less than one hundred dollars (\$100).

ARTICLE V
PREEMPTIVE RIGHTS

There shall be no preemptive rights of any stock hereby issued or hereafter issued.

ARTICLE VI
DURATION

This corporation is to exist perpetually.
