ARTICLES OF INCORPORATION

OF

The undersigned incorporator does hereby make, subscribe, file and acknowledge these Articles of Incorporation for the purpose of organizing a corporation under the Florida Business Corporation Act.

ARTICLE I NAME OF CORPORATION

The name of the corporation is James & Street GP, Inc. (hereinafter, the "Corporation").

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The mailing address and principal office of the Corporation is: 321 E. Broward Blvd., Deerfield Beach, Florida 33441.

ARTICLE III AUTHORIZED SHARES

The total authorized capital stock of the Corporation shall consist of 10,000 shares of Common Stock, par value \$0.01 per share. In the event of any liquidation, dissolution or winding-up of the Corporation, whether voluntary or involuntary, the holders of Common Stock are entitled to share ratably in the net assets, if any, remaining after payment in full of all debts and liabilities of the Corporation and after the holders of any outstanding class or series of capital stock ranking senior to Common Stock shall have been paid in full the amounts to which such holders shall be entitled, or an amount sufficient to pay the aggregate amount to which such holders are entitled shall have been set aside for the benefit of the holders of such senior capital stock.

ARTICLE IV ADDRESS OF REGISTERED OFFICE IN THIS STATE

The street address of the initial registered office of the Corporation in the State of Florida is 321 E. Hillsboro Blvd., Deerfield Beach, Florida 33441, and the initial registered agent of the Corporation at that address shall be Brian Street.
