### ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION ANN MARIE CROOKS, INC.

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation filed July 2, 2003, under document number P03000073247.

#### **ARTICLE I**
