ARTICLES OF INCORPORATION OF

Pangea Medica, Inc.

ARTICLE 1. - NAME

The name of this corporation is **Pangea Medica, Inc.**

ARTICLE 2. - PRINCIPAL OFFICE: MAILING ADDRESS

The principal office of the corporation is initially 6515 15th Street East D-1, Sarasota, FL 34243-3292 and the mailing address of the corporation is initially 6515 15th Street East D-1, Sarasota, FL 34243-3292. The corporation may change its principal office and/or mailing address from time to time as permitted by law.

ARTICLE 3. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

The corporation may purchase and maintain insurance on behalf of all officers and directors against any liability asserted against them or incurred by them in their capacity as officers and directors or arising out of their status as such.


