ARTICLE I - NAME OF CORPORATION

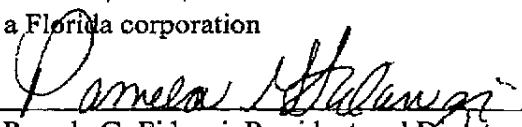
The name of the Corporation is **MEDTEAM STAFFING, INC.**
