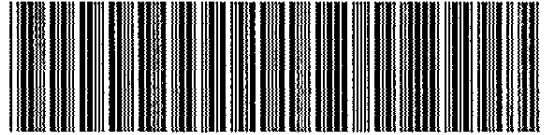

ARTICLE I - NAME

The name of this corporation is KWFGP, INC. and the address is 2070 Orange Blossom Trail, Apopka, Florida 32703.

ARTICLE II - TERM OF EXISTENCE

This existence of this corporation shall exist perpetually.



ARTICLE X - LIMITATIONS ON AMENDMENT


These Articles of Incorporated may be amended only by the vote or written consent of the holder of seventy-five percent (75%) of the outstanding shares entitled to vote.
