
ARTICLE IX

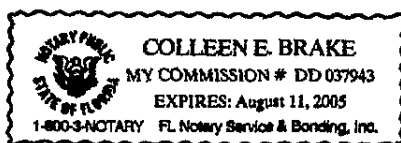


