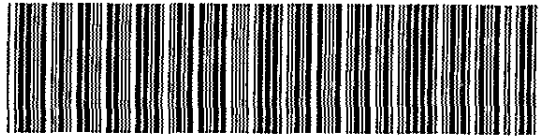

Article I
