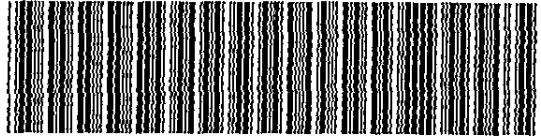

ARTICLES OF INCORPORATION

OF

R & D ELECTRIC OF BROWARD, INC

The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida General Corporation Act.

FIRST: The name of the corporation (hereinafter called the corporation) is  
R & D Electric of Broward, Inc.

SECOND: The duration of the corporation shall be perpetual.

THIRD: The purposes for which the corporation is initially organized, which shall continue to be the purpose of the corporation until and if the same shall be amended pursuant to the provisions of the Florida General Corporation Act, and which shall include the authority of the corporation to transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act, are as follows: To carry on as a subcontractor in the electrical industry. To service, maintain, install any equipment associated or incidental to or connected with, any of the purposes or business of the corporation; and generally to perform any and all acts connected therewith or arising therefrom of incidental thereto, and all acts proper or necessary, and lawful for the purpose of business.  
To have all of the powers conferred upon corporations organized under the Florida General Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1000, all of which are without par value and are of the class and are to be Common Shares.

FIFTH: The address of the initial registered office of the corporation in the State of Florida is c/o R & D Electric of Broward, Inc., 5222 NW 80th Terrace, Parkland, Florida, 33067; and the name of the initial registered agent of the corporation at such address is Robin Lee Rivera.

SIXTH: The number of directors constituting the initial Board of Directors of the Corporation is one (1).

EIGHTH: 1. Whenever the corporation shall be engaged in the business of exploiting natural resources or other wasting assets, dividends may be declared and paid in cash out of the depletion or similar reserves at the discretion of the Board of Directors and in conformity with the provisions of the Florida General Corporation Act.

2. The corporation shall, to the fullest extent permitted by the provisions of the Florida Corporation Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any By-Law, agreement, vote of shareholders or disinterested directors or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director of the heirs, executors, and administrators of such a person.
