The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, Florida Statutes § 607.0101, et seq., hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Corporation shall be: **GUICHELLE PETITTE ACADEMY & PRESCHOOL, Inc.,**

ARTICLE II

PRINCIPAL PLACE OF BUSINESS

ARTICLE III

PURPOSE

The purpose for which the corporation is organized is: To educate and to equip students so they can transform the world through Christ. 
