ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND ADDRESS

The name of this corporation will be PINK SAND, INC., with its principle address and mailing address being 3621 SW 23rd Ct., Ft. Lauderdale, Broward County, Florida 33312.

ARTICLE II - NATURE OF BUSINESS

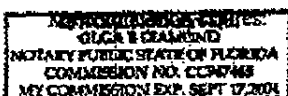
