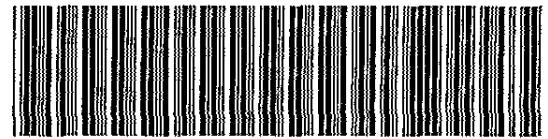



FIRST: The following amendment to the Articles of Incorporation was adopted by unanimous consent of the shareholders of the corporation.


Article 1 of the Articles of Incorporation is hereby deleted and in lieu thereof a new Article 1 is hereby inserted:
