Conflict of Interest



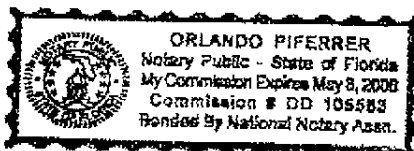


