**ARTICLES OF INCORPORATION

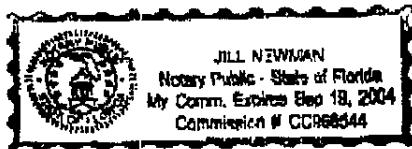
