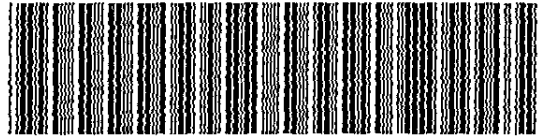

ARTICLES OF INCORPORATION


**ARTICLE VIII


