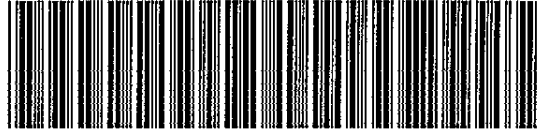

### **ARTICLE I - NAME**
