We, the undersigned, in order to form a Corporation for profit for the purpose hereinafter state, under the pursuant to the provision of the Florida Statutes, do hereby subscribed to this certificate of Incorporation, and do adopt the following Articles of Incorporation:

ARTICLES OF INCORPORATION

ARTICLE I

The name of Corporation shall be:

ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on by this corporation shall be:

- a. This Corporation is organized with the purpose to engage in installation & repairs of marbles, and tiles, floor services and all other lawful related activities permitted under the laws of the State of Florida and the United States of America.
