ARTICLE OF INCORPORATION

OF

The undersigned subscribes to these Articles of Incorporation, each a natural person competent to contract, hereby forms a corporation under the laws of the State of Florids.

ARTICLE I

NAME: The name of this corporation is: FIDELITY REALTY ADVISORS, INC.
