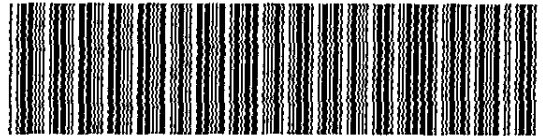



The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. Name: The name of the corporation is **ADAM EXP., INC.** The address of the corporate office shall be 11680 Cardenas Blvd., Boynton Beach, Florida 33437.

ARTICLE II. Duration: The period of this corporation's duration is perpetual.

ARTICLE III. Purpose: The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida, including delivery of Federal Express packages.


