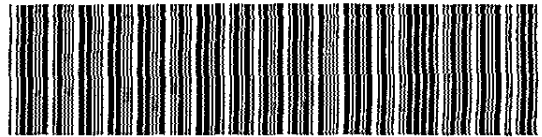

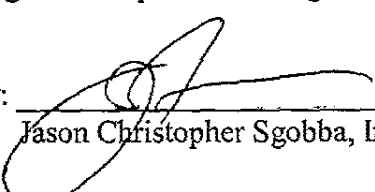

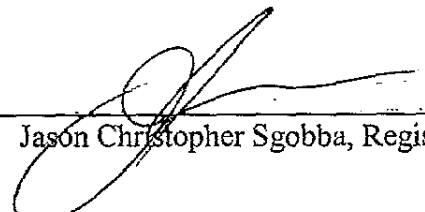

**ARTICLES OF INCORPORATION
OF
R. S. HANLEY DESIGN SERVICES, INC.**

THE UNDERSIGNED, acting as the sole Incorporator of **R. S. HANLEY DESIGN SERVICES, INC.**, under the Florida Business Corporation Act, Chapter 607, Florida Statutes, as hereafter amended and modified, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

Name

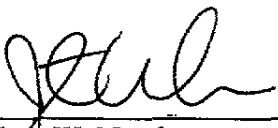
