The undersigned, for the purpose of forming a S corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE ONE**

**NAME**

The name of the corporation is **SCHOOL SPIRIT SUPPLIES, INC.**

**ARTICLE TWO**

**PRINCIPLE OFFICE**

The street address of the initial principle office is P.O. Box 1445, Crestview, Florida 32536 and the mailing address of the corporation is 1412 N. Lloyd Street, Crestview, Florida 32536.

**ARTICLE THREE**

**CORPORATE DURATION**

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is July 1, 2003, at 12:01 a.m., central time

**ARTICLE FOUR**

**PURPOSE OR PURPOSES**

1. The general purpose for which the corporation is organized is to engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

2. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

## **ARTICLE FIVE**

### **CAPITALIZATION**

The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 25 persons. Stock will be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust defined in Section 1361 (c)(2)(or its successor section) of the Internal Revenue Code. In addition, no stock shall be issued or transferred to a non-resident alien.

The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be of a single class, and shall have a par value of \$10.00 per share.
