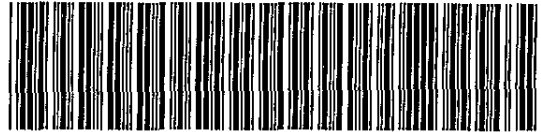

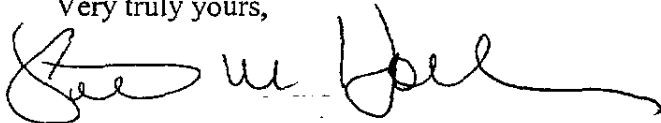

ARTICLE I - NAME

The name of this corporation is SAR-TRES CORP.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III - DURATION

This corporation shall have perpetual existence, commencing upon the 1st day of July, 2003, being the same date as the subscription to and acknowledgment of these Articles of Incorporation.

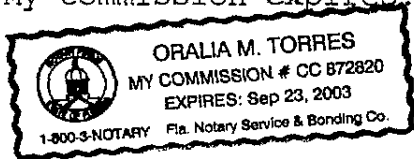
