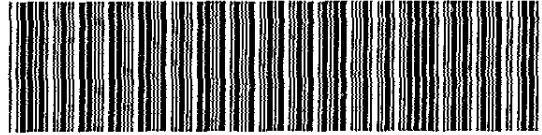

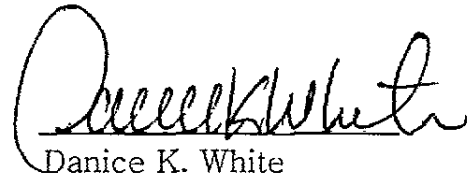
Article XIII:Amendment

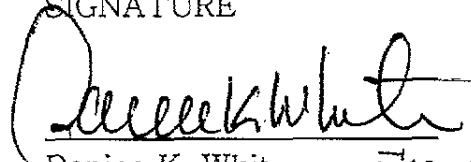

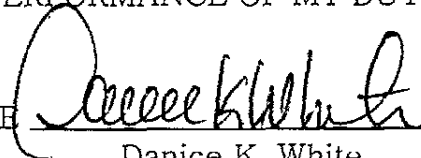
