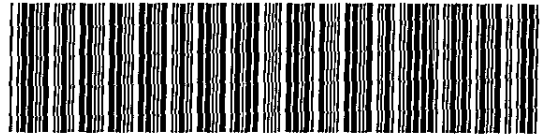

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of the Corporation is Larry Batchelor Mechanical, Inc.

ARTICLE II

DURATION

The period of duration of the Corporation shall be perpetual, unless hereafter lawfully dissolved.

ARTICLE III

PURPOSES

The purposes for which the Corporation is organized are to engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida, including, but not limited to, heating and air conditioning installation and service, and the powers which it shall have are all of the powers available to a corporation incorporated in this state and, to the extent it is doing business in another state, all such additional powers as are available to a corporation doing business in such other state.

ARTICLE IV
CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is ten thousand (10,000) shares of common stock, \$1.00 par value.

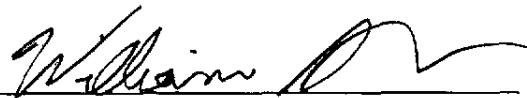

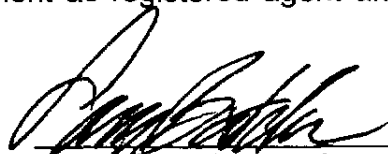
