Any action of the stockholders of the corporation must be taken at a meeting of the stockholders of the corporation duly called as provided by law.


ARTICLE X - INDEMNIFICATION:

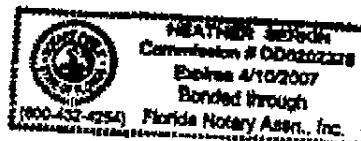


