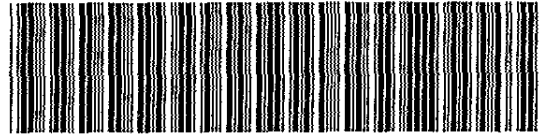


ARTICLES OF INCORPORATIONS
