ARTICLES OF INCORPORATION OF GOT-LEW, INC.

. The undersigned Incorporators, James E. Gottschalk and Clifford A. Lewis, Jr., for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be GOT-LEW, INC.

ARTICLE II

The Corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III

The Corporation shall have the power to engage in any lawful activity for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE IV

The aggregate number of shares that the Corporation shall have authority to issue and to have outstanding at any one time is One Thousand (1,000).
