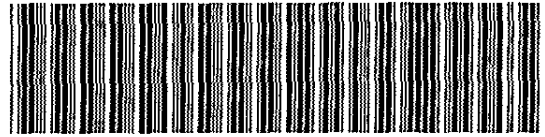

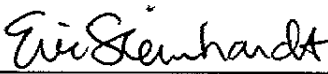
## ARTICLE VIII

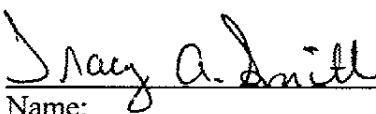
