ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is McGOWIN AND WARD CONSTRUCTION, INC., whose principal office or mailing address is 912 Cheetah Trail, Apopka, Florida 32712.

ARTICLE II - DURATION
