ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is Prime Movers Rehab, Inc. at 919 Pinewalk Court NE, Palm Bay, FL 32905 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
