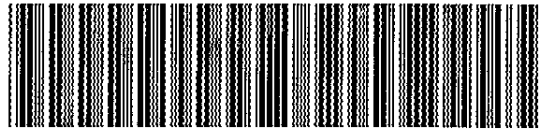



**III. Registered Office**






