ARTICLES OF INCORPORATION

OF

HORSE DRAWN CARRIAGES, INC.

The undersigned incorporator to these Articles of Incorporation, a Florida corporation, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of the Corporation is HORSE DRAWN CARRIAGES, INC.

ARTICLE II - NATURE OF BUSINESS AND POWERS
