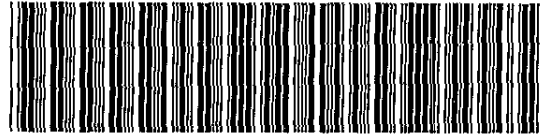

ARTICLES OF INCORPORATION  
OF  
ARROWHEAD HOLDING COMPANY, INC.

The undersigned Incorporators, for the purpose of forming a Corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is Arrowhead Holding Company, Inc.

ARTICLE TWO

PRINCIPAL OFFICE AND ADDRESS

The address of the principal office of the Corporation is 4820 Highway 90 East, Marianna, Florida 32446 and the mailing address of the Corporation is 4820 Highway 90 East, Marianna, Florida 32446.

ARTICLE THREE

SHARES, CLASS AND PAR VALUE

The Corporation is authorized to issue one class of shares, which shall be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution. The Corporation is authorized to issue 1,000 common shares, and shall have a par value of \$1.00 each.
