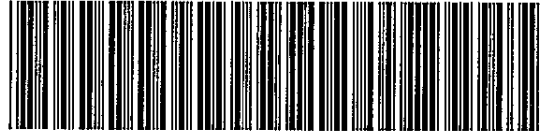

ARTICLES OF INCORPORATION
OF

AMERICAN PAINTING & WATERPROOFING INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation is:

AMERICAN PAINTING & WATERPROOFING INC.

ARTICLE II

The purpose for which the Corporation is organized is to engage in any activities or business permitted under the laws of the United States and Florida.

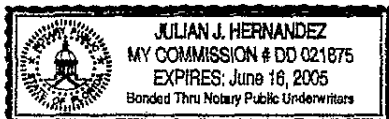
