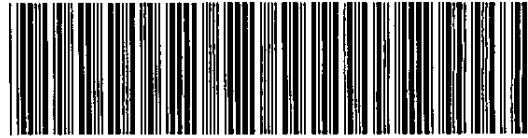

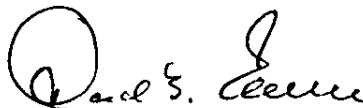

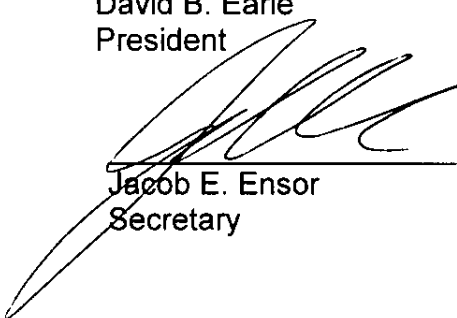
**ARTICLES OF AMENDMENT
