



**FIRST AMENDMENT TO ARTICLES OF INCORPORATION  
OF TRES BELLE HOMEOWNERS ASSOCIATION INC.**

THIS IS THE FIRST AMENDMENT TO THE ARTICLES OF  
INCORPORATION OF TRES BELLE HOMEOWNERS ASSOCIATION, INC.  
(this "First Amendment"), is made as of February 18, 2022.

**RECITALS:**

WHEREAS, the Articles of Incorporation of Tres Belle Homeowners Association Inc. (the "Association") was recorded for the purposes of forming this non-for profit corporation under the Laws of the State of Florida on the 4<sup>th</sup> day of August, 2004.

WHEREAS, at a duly noticed meeting of the Members of the Association, a quorum of the Members, and a quorum of the Board of Directors. The Members per ARTICLE X, Section 3., affirmatively voted to pass the First Amendment to the Articles of Incorporation.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Articles of Incorporation are hereby amended as follows:

**Article VIII  
Board of Directors**

The affairs of this Association shall be managed by a Board of Directors consisting of not less than three (3) nor more than seven (7) persons who must be members of the Association. The first Board shall consist of three (3) members. The number of Directors may be increased up to the maximum of seven (7) upon the first election of Directors, as provided in the Bylaws.

Directors of the Association shall be elected at the annual meeting in a manner provided by the Bylaws. Directors may be removed and vacancies on the Board shall be filled in the manner provided by the Bylaws.

Full Force and Effect. Except as otherwise amended herein, all other terms and provisions of the Articles of Incorporation shall remain in full force and effect.


