OF

**ARTICLE I
NAME**

The name of this Corporation is Inter-Energy, Inc.

**ARTICLE II
PURPOSE**

This Corporation is organized for the purpose of conducting any and all lawful business which may be conducted by business corporations organized in the State of Florida.

**ARTICLE III
INITIAL PRINCIPAL OFFICE**

**ARTICLE IV
AUTHORIZED SHARES**

This Corporation is authorized to issue Six Hundred (600) shares of Common Stock.

**ARTICLE V
INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this Corporation is 20517 S.W. 2nd Street, Pembroke Pines, Florida 33029, and the name of its initial registered agent at that address is Anita Gomez.

**ARTICLE VI
PREEMPTIVE RIGHTS**

Every shareholder, upon the sale of any new stock of this Corporation of the same kind, class or series as that which the shareholder already holds, shall have the right to purchase his or her pro rata (as nearly as may be done without the issuance of fractional shares), at the price, and upon identical terms and conditions at which such new shares are offered to others.

**ARTICLE VII
CUMULATIVE VOTING**

At each election for directors, every shareholder entitled to vote in the election shall have the right to cumulate his or her votes, by giving one candidate as many votes as the number of directors to be elected at that time, multiplied by the number of his or her shares, or, in the alternative, by distributing the votes on the same principle among any number of the candidates.

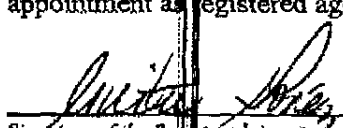
