ARTICLE I NAME

The name of this Corporation is Inter-Energy, Inc.

ARTICLE IV AUTHORIZED SHARES

This Comporation is authorized to issue Six Hundred (600) shares of Common Stock.

At each dection for directors, every shareholder entitled to vote in the election shall have the right to cumulate his or her votes, by giving one candidate as many votes as the number of directors to be dected at that time, multiplied by the number of his or her shares, or, in the alternative, by distributing the votes on the same principle among any number of the candidates.
