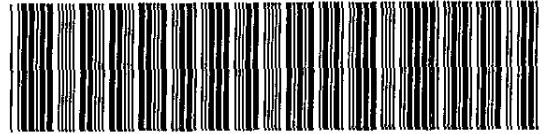

Pursuant to the Florida Business Corporation Act, Sections 607.1006 and 607.1005, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is Star Music Retailers, Inc. IV (document number P03000076765).
2. Article I of the Articles of Incorporation of the corporation shall be amended in its entirety to read as follows:


**“ARTICLE I— NAME**
