The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract, subscribes to and forms a corporation for profit under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation is; BATMAN & ROBIN MARKETING GROUP, INC.

## **ARTICLE II - NATURE OF BUSINESS**

The corporation may engage in any activity of business, permitted under the laws of the United States and of this State. These activities may include, but are not in anywise limited to the operation of the following;


