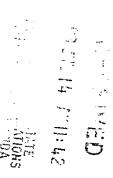

### ARTICLES OF INCORPORATION

OF

### MAITLAND SECURITIES, INC.

The undersigned, acting as the Incorporator of MAITLAND SECURITIES, INC., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

### **ARTICLE I - NAME**

The name of the Corporation is MAITLAND SECURITIES, INC. The mailing address of the Corporation shall be 1101 North Lake Destiny Road, Suite 225, Maitland, Florida 32751.

### ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

### **ARTICLE III - DURATION**

The Corporation shall exist perpetually.

### **ARTICLE IV - PURPOSE**
