ARTICLES OF INCORPORATION
OF

PURSUANT TO Sections 621.05, 621.13, and 607.0202, Florida Statutes (1998), the undersigned, acting as sole incorporator of ADVANCED AESTHETIC SURGERY CENTER, P.A., hereby adopts and files the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is ADVANCED AESTHETIC SURGERY CENTER, P.A.

ARTICLE II

Purpose

The purpose for which the corporation is organized is the rendition of professional services to the public by physicians and surgeons. The corporation is a professional service corporation governed by Chapter 621, Florida Statutes.

ARTICLE III

Principal Office and Mailing Address

The address of the principal office and the mailing address of the corporation is 7975 Lake Underhill Road, Suite 150, Orlando, Florida 32822. The location of the principal office shall be subject to change as may be provided in bylaws duly adopted by the corporation.

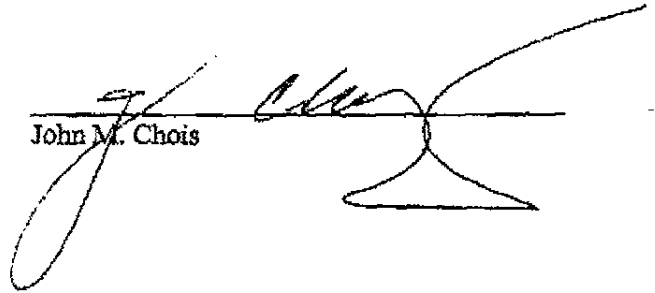
