PURSUANT to the provisions of Section 607.1006 of the Florida Business Corporation act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is American Title Abstracts & Escrow Services, Inc.

2. The text of the amendment is as follows:

The authorized \$1.00 par value common stock of the Corporation is hereby increased from 100 shares of authorized \$1.00 par value common stock to 50,000 shares of authorized \$1.00 par value common stock.


3. The amendment was adopted on the 31<sup>st</sup> day of October, 2005.
