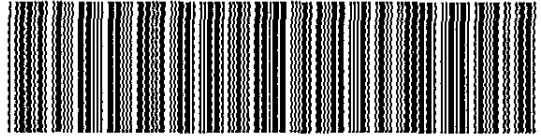

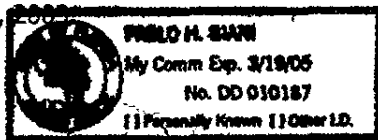
ARTICLE IX – BYLAWS
