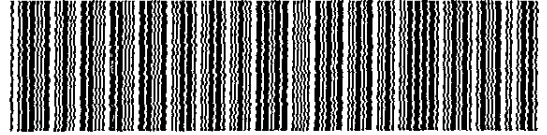

BY-LAWS



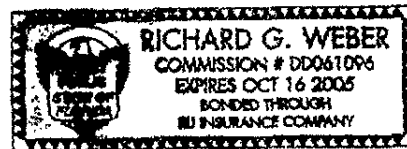
