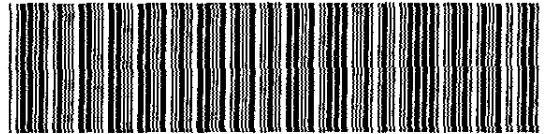

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is COLLINS PAINTING, INC.

ARTICLE II

The existence of the Corporation shall be the date on which it is legally formed.

ARTICLE III

The street address of the principal office of the Corporation is 7313 SW 155TH STREET, DUNNELLON, FL 34432

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is TWENTY (20), par value \$.01 per share, all of which shall be Common Shares.
