**ARTICLES OF INCORPORATION
OF
AMERICAN MOBILE MEDICINE, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is American Mobile Medicine, Inc. (the "Corporation").




